Herewith we transfer the approval as "BMW Longlife-04" oil, given for "**Confidential**", SAE 5W-30, engine oil code **Confidential** of "Infineum UK Limited" to the blend oil "LUKOIL GENESIS SPECIAL VN", SAE 5W-30 (oil code **Confidential**) of OOO LLK-International. Consequently it is approved according to our release procedure for BMW Longlife engine oils (7th edition, 2016) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter and can be extended no more than two times for a maximum of two years in each case. Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBL-2016-00321.
